Dear Participant:

The State Bar Annual Meeting will present its Fifty-Fourth Annual Bench and Bar Art Exhibit in Monterey from October 5<sup>th</sup> through October 8<sup>th</sup>. You are invited to enter your best works and participate actively in this enjoyable event.

The exhibit will occupy a space in the Steinbeck Lobby of the Monterey Conference Center. This year's exhibit hours will be Thursday, October 5<sup>th</sup> from 5:45 p.m. to 8:00 p.m., Friday, October 6<sup>th</sup> from 10:00 a.m.-5:00 p.m. and Saturday, October 7<sup>th</sup> from 11:00 a.m. to 7:00 p.m. The Art Exhibit will be dismantled on Sunday, October 8<sup>th</sup> between 9:00 a.m. and 12:00 noon.

This year the Art Show will be in the Steinbeck Lobby of the Monterey Conference Center and will be part of the "Opening Night Reception" which begins at 5:45 p.m. You must deliver your entries to the Art Show area between 11:00 a.m. and 2:30 p.m. on Thursday, October 5<sup>th</sup>. The show must be hung **before** 3:00 p.m. on Thursday so that the judging may be completed by 5:45 p.m.

You are responsible for your own pieces. You must retrieve your entries by 12:00 noon on Sunday, October 8<sup>th</sup>. There will be no transportation of artwork to or from the exhibit, nor will there be any insurance provided for the entries during the show. If you are concerned about the possibility of loss or damage to your work, you should obtain your own insurance coverage.

To insure the success of your exhibit, **the committee needs your help**. We need volunteers to hang the show on Thursday, October 5<sup>th</sup>, to staff the show throughout the meeting and to take down the exhibits on Sunday, October 8<sup>th</sup>. Since this is your show, please consider volunteering an hour or two of your time to help staff the show. Please indicate your willingness to participate in these activities in the space provided on the entry blanks. We particularly need your help hanging the art. The time spent at the art show is very enjoyable. You have the opportunity to meet your colleagues and share your artistic interests with them. Your willingness to volunteer your time and talents will assure an enjoyable, successful show!

Catalogues and award ribbons will be provided at the show. An entry blank and identification form is enclosed. Please complete your entry blanks and send them to Cheryl Morgan, Department of Meeting Services, State Bar of California, 180 Howard Street, San Francisco, CA 94105. It is important for the committee to have an early indication of the size and content of the show. **Entry deadline is September 1, 2006.**
